



## THE 25 BY 25 PARTNERSHIP FINALLY GATHERED FOR A FACE-TO-FACE PROJECT MEETING IN SOFIA, BULGARIA!

On the 6th and 7th of July representatives of the partner organisations joined forces in Sofia, Bulgaria for making progress on the finalisation of current tasks and intellectual outputs and discussing future remaining activities.

The agenda went through a review of all the intellectual outputs and discussed the present state of our common dissemination efforts, immediate and future quality assessment plans and testing opportunities and deadlines. The partners decided on bringing all intellectual outputs into a testing-ready state by the end of the summer so that in September and October 2022 proper trials with youth workers and young people can take place for the purpose of checking accessibility, usability and usefulness of the results of our work.

### Matrix of Cultural Experiences across Europe

The partners finalised the second output, the **Matrix of Cultural Experiences across Europe**. It is ready and available in EN and by September will be accessible also in all partner languages. The technical partner under the project is including all the elements of the matrix online, as separate cultural activities, in order to make the 25 by 25 as interesting, attractive and developing experience for the users as possible.

The 25 by 25 Matrix is addressed towards NEET youths and young people, but it also allows youth workers to learn about cultural experiences across Europe and inspire them to look at the ones available in their area from a different perspective and build on those.
